GENERAL CONDITIONS OF SALE AS PER INSTITUTE OF AUCTIONEERS AND APPRAISERS IN SCOTLAND GUIDELINES ARE AVAILABLE IN OFFICE WITH SPECIFIC VARIATIONS AS LISTED BELOW

- ALL CATTLE MUST BE EAR-TAGGED AND IDENTIFIED SEPARATELY BY MEANS OF A LARGE TAG, PAINT MARK, GLUED TICKET ETC.
- SHOULD ANY HEIFER PROVE IN CALF, A CLAIM OF ONE THIRD OF THE PURCHASE PRICE WILL HAVE TO BE REFUNDED TO THE EXPOSER, OR AT THE PURCHASERS OPTION, THE HEIFER MAY BE RETURNED TO THE SELLER WHO WILL BE REFUNDED THE PURCHASE PRICE PLUS KEEP AND EXPENSES AS FIXED BY THE AUCTIONEERS. ALL CLAIMS MUST BE NOTIFIED BEFORE CALVING.
- ANY MALE CALVES WHICH HAVE BEEN SOLD AS PROPERLY CASTRATED AND PROVE NOT TO HAVE BEEN MUST BE INTIMATED TO THE AUCTIONEERS WITHIN 14 DAYS OF THE DATE OF SALE.
- ANY PARTY SUCCESSFULLY BIDDING ON A LOT WILL BE DEEMED TO BE LIABLE FOR THAT ACCOUNT UNLESS PREVIOUSLY AGREED WITH THE MANAGEMENT.

IT IS THE DUTY OF ALL CONSIGNERS OF LIVESTOCK TO NOTIFY AUCTIONEERS AT THE POINT OF SALE OF ANY WITHDRAWAL PERIODS WHICH MAY APPLY TO THE STOCK THEY OFFER FOR SALE. IT IS A LEGAL REQUIREMENT THAT A FOOD CHAIN INFORMATION DECLARATION BE PRESENTED WITH STOCK. DECLARATIONS ARE AVAILABLE FROM THE MAIN OFFICE OR VIA WEBSITE. ANY PURCHASER WISHING TO PURCHASE STORE ANIMALS FOR SLAUGHTER PLEASE INFORM THE OFFICE PRIOR TO PURCHASE.
