NOTE - SPECIAL CONDITIONS - CATTLE

GENERAL CONDITIONS OF SALE AS PER INSTITUTE OF AUCTIONEERS AND APPRAISERS IN SCOTLAND GUIDELINES ARE AVAILABLE IN OFFICE WITH SPECIFIC VARIATIONS AS LISTED BELOW

1. IN THE EVENT OF AN ANIMAL BEING SOLD WITH NO WARRANTY OR UNDER £150 IN PRICE, NO COMPLAINT OF ANY KIND WILL BE ENTERTAINED.
2. ALL CALVING COWS AND HEIFERS SOLD AS TIME UP, OR COMING TO CALVING, THE CALVING DATE SHALL BE RECKONED AS FROM THE DATE OF SALE. ANY SUCH ANIMAL NOT CALVING WITHIN THE PERIOD OF 21 DAYS MAY BE REJECTED BY THE PURCHASER WHO MUST NOTIFY THE AUCTIONEERS IN WRITING ON THE EXPIRY OF THAT PERIOD.
3. ALL ANIMALS SOLD AS SPRING CALVERS WITH NO SPECIFIED TIME MUST CALVE BEFORE 1ST MAY.
4. COWS OR HEIFERS SOLD AS CALVERS PROVING TO BE EILD MAY BE REJECTED WITHIN 49 DAYS. INTIMATION, IN WRITING ACCOMPANIED BY A VETS. CERTIFICATE, TO THE AUCTIONEERS WITHIN THAT PERIOD TO THE EFFECT THAT THE ANIMAL IS NOT IN CALF SHALL ENTITLE THE PURCHASER TO RETURN THE ANIMAL TO THE EXPOSER AND RECOVER FROM HIM THE PRICE THEREOF TOGETHER WITH THE KEEP AND TRANSPORT EXPENSES DUE.
5. SHALL AN ANIMAL NOT CALVE WITHIN 21 DAYS FROM THE DATE SPECIFIED AT THE TIME OF SALE THE PURCHASER SHALL INTIMATE IN WRITING TO THE AUCTIONEERS AND SHALL KEEP THE ANIMAL UNTIL SHE CALVES AFTER WHICH THE PURCHASER SHALL BE ENTITLED TO RECOVER, FROM THE EXPOSER, THE COST OF KEEP FROM THE EXPIRY OF THE 21 DAYS TO THE DATE OF CALVING PLUS 2% OF THE ORIGINAL COST OF THE ANIMAL PER WEEK.
6. IN ALL CASES WHERE A CLAIM FOR KEEP ARISES UNDER THESE CONDITIONS, THE SAME SHALL BE AT THE RATES FIXED BY THE AUCTIONEERS. NO CLAIM SHALL ARISE AT THE INSTANCE OF A PURCHASER AGAINST AN EXPOSER IN RESPECT OF ANIMALS SOLD AS CALVERS SLIPPING A CALF.
7. ALL COMPLAINTS UNDER THE FOREGOING MUST BE IN WRITING TO THE AUCTIONEERS AND MUST BE ACCOMPANIED BY VETERINARY CERTIFICATES.
8. THE AUCTIONEERS TIME BOOK AND CLERKS ROLL SHALL BE SUFFICIENT EVIDENCE OF ANY STATEMENT MADE BY OR ON BEHALF OF THE EXPOSER.
9. ANY COW MINUS A TOOTH OR TEETH OR SHORT TOOTHED IS CONSIDERED INCORRECT THEREFORE VENDORS MUST STATE THIS FAULT AT THE TIME OF SALE OTHERWISE THE PURCHASER CAN REJECT THE ANIMAL BEFORE IT LEAVES THE MART.
10. ANY COMPLAINTS REGARDING UNSOUNDNESS OF VESSELS IN ANY HEIFER OR COW, MUST BE MADE BEFORE THE ANIMAL LEAVES THE MART OR WITHIN 2 HOURS OF COMPLETION OF SALE.
11. CATTLE PASSPORTS - ALL CATTLE MUST BE ACCOMPANIED BY A CATTLE PASSPORT.
12. ALL CATTLE MUST BE EAR-TAGGED AND IDENTIFIED SEPARATELY BY MEANS OF A LARGE TAG, PAINT MARK, GLUED TICKET ETC.
13. SHOULD ANY STORE HEIFER PROVE IN CALF, A CLAIM OF ONE THIRD OF THE PURCHASE PRICE WILL HAVE TO BE REFUNDED TO THE EXPOSER, OR AT THE PURCHASERS OPTION, THE HEIFER MAY BE RETURNED TO THE SELLER WHO WILL BE REFUNDED THE PURCHASE PRICE PLUS KEEP AND EXPENSES AS FIXED BY THE AUCTIONEERS. ALL CLAIMS MUST BE NOTIFIED BEFORE CALVING.
14. ANY MALE CALVES WHICH HAVE BEEN SOLD AS PROPERLY CASTRATED AND PROVE NOT TO HAVE BEEN MUST BE INTIMATED TO THE AUCTIONEERS WITHIN 14 DAYS OF THE DATE OF SALE.
15. FOOD CHAIN INFORMATION DECLARATIONS ARE AVAILABLE FROM THE MAIN OFFICE OR VIA WEBSITE. IT IS THE DUTY OF ALL CONSIGNERS OF LIVESTOCK TO NOTIFY AUCTIONEERS AT THE POINT OF SALE OF ANY WITHDRAWAL PERIODS WHICH MAY APPLY TO THE STOCK THEY OFFER FOR SALE AND IT IS ALSO THE RESPONSIBILITY OF THE BUYER TO ENSURE THAT ANY ANIMALS DESTINED FOR THE FOOD CHAIN ARE OUTWITH ANY WITHDRAWAL PERIOD.
16. DISPERSAL SALE CONDITIONS - WHILST ANY PARTICULARS GIVEN ARE BELIEVED TO BE CORRECT NO WARRANTY IS GIVEN OR IMPLIED.
17. ANY ANIMAL BEING RETURNED FOR NOT CONFORMING TO WARRANTY WILL BE SUBJECT TO WARRANTY WILL BE SUBJECT TO THE 13 DAY MOVEMENT RESTRICTION.
